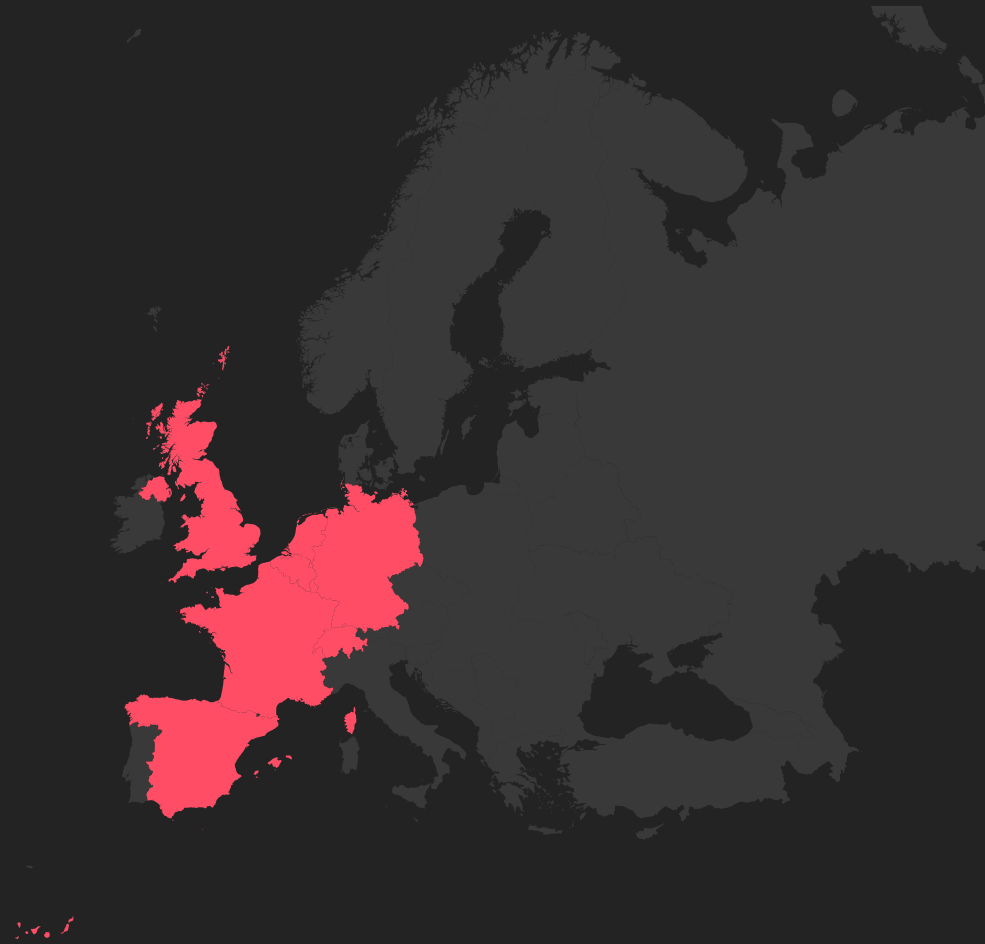

European overview

In the dynamic landscape of 2024, we are continuing to see the role of interim management grow across global markets.

Whilst previously seen as a more desirable career move for senior, experienced professionals looking to extend their working years, we are now seeing a wider mix of people across all professions making interim assignments their long-term career choice.

The results of our recent global Robert Walters interim management survey show that the opportunity to develop skillsets and leadership skills in a defined period of time, together with the more varied workload offered by interim assignments, are the top reasons why candidates are looking to complete interim management assignments in 2024. The ability to focus more on problem solving and creating solutions, and less on daily routine tasks, gives an interim manager the opportunity to continuously expand their knowledge and skills, which is one of the reasons we are seeing more individuals from younger generations make the move into interim assignments. For those who have the right skills and mindset, completing interim assignments can be an exciting and fulfilling career path with many rewards and benefits.

From a business point of view, demand for interim talent remains strong, thanks to a changing economic context that makes long-term projection difficult, and to organisations still facing recruitment challenges. In 2024, organisations will be using the flexibility and cost effectiveness that interim managers can offer them. 43% of our existing clients are planning to recruit more interim talent in the next 12 months. Although we are seeing growth in all functions, change management is the most important area for organisations recruiting new interim managers, with senior executives who have the ability and expertise to drive and lead change being the most sought-after.

In 2024, we will continue to see developments in technology in areas such as AI, as well as organisations continuing to focus on delivering ESG and CSR-related projects. More than ever, companies will need experts in these areas who can adapt to changing environments. For companies that want to get ahead of their competitors and achieve their goals in a timely and cost-effective manner, interim management could also be the answer. Interim talent will ultimately enable companies to get access to senior level experts on a shorter-term basis who can have an immediate impact and steer their business in the right direction from day one.

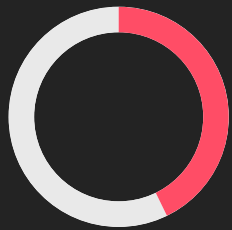

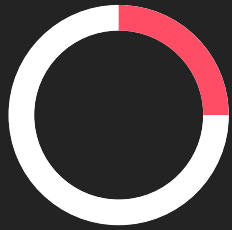

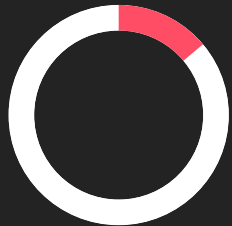

Why companies hired interim managers in the last 12 months:



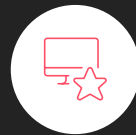
